

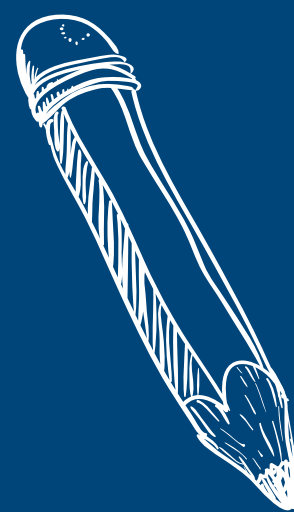


We want your help to raise awareness about why *Every Breath Matters* in the OR!

- Horizontal orientation is preferable.



Winners will be announced monthly and receive a \$2000 educational grant for their AORN Chapter.

Posters will be evaluated based on content, creativity, and communication of the importance of a smoke free environment.

TERMS AND CONDITIONS

1. Eligibility

Must be an AORN Member with an active designated AORN Chapter that is a 501(c)(3) charitable organization to participate. Each entry is only eligible for one prize. Void where prohibited by law.

2. Sponsorship

This contest is sponsored by CONMED Corporation, 11311 Concept Blvd, Largo FL 33773. Educational grants awarded hereunder shall be used solely for educational purposes by a valid 501(c)(3) AORN Chapter. CONMED and its affiliates (“CONMED”) reserves the right to audit the use of any grant awarded hereunder.

3. Entry Period

The contest will run from May 5, 2022 through October 31, 2022.

4. Agreement to Rules

By submitting an entry via email you agree to be bound by these Terms and Conditions and to all decisions made by CONMED in relation to the selection of winners.

5. How to Enter

Create an individual or group E-Poster sharing your story/journey in going smoke free in the operating room (the “Materials”). E-Posters must be one page (PowerPoint or PDF); horizontal orientation preferred. A second page for references will be accepted. You must provide your name, email address, phone number and AORN Chapter designation and a signed copy of these Terms and Conditions with your submission. Submissions must be received by email at everybreathmatters@conmed.com. To be eligible for each month’s grant, the Materials must be submitted by the last day of the month. Non-winning submissions will be re-enrolled for the remainder of the contest period. Failure to include a signed copy of these Terms and Conditions will result in disqualification of your submission.

6. Monthly Educational Grant

The AORN Chapter for each monthly winner will be provided a \$2,000 restricted grant for educational purposes. Winners will be selected monthly. Only one grant per Chapter will be awarded for the duration of the contest. Winners will listed on CONMED’s website: Everybreathmatters.com and social media pages (LinkedIn – @CONMED Advanced Surgical; Facebook – @CONMED Corporation). This contest is neither sponsored by nor endorsed by LinkedIn or Facebook.

7. Selection and Notification of Winners

Winners will be selected by a panel of judges at CONMED Corporation based on content, creativity and communication of the importance of a smoke free operating room environment. Winners will be notified by email.
